**CEMETERY RULES AND REGULATIONS: All burials, memorials and plaques must abide by the Rules and Regulations of Temple Balsall Cemetery. #### Notes

\* Fees paid for an Exclusive Right of Burial are not refundable, but ownership can be transferred.

\*\* i) A resident is someone whose main residence is within the parish council's boundaries at the time of their death or on the electoral roll of St Mary the Virgin Church or St Peter's Church at the time of their death. Residents may have a postal address of "Balsall Common" but not be a resident of the Parish. Details of the boundary and a street list of Balsall Parish can be found on the website or from the Clerk.

ii) People who have lived more than 10 years within the parish council's boundary and then move directly to a care home, hospice or hospital outside the parish council's boundary for a period of not greater than 5 years upon their death will be classed as residents.

iii) People who have lived in Chadwick End since before Chadwick End Parish Council was established on 1st April 2014 will be charged at the resident's rate.

iv) The Parish Council will exercise its discretion to judge whether a non-resident of the parish (other than defined by i), ii) or iii) above) can be charged at the resident's rate. In the instances where they are, The Parish Council Cemetery Committee will make the decision to grant permission. **Please be advised this will take a minimum of 5 working days.** Examples of where this permission might be granted are:

1. Strong links to the parish through voluntary work for the parish benefit.
2. Strong links to close family members already buried in the cemetery.
3. Where the deceased is aged 25 years old or below and whose immediate next of kin are their parents who are classed as residents. Examples of where this might be the case are full-time students.
